 - MVG window decal and banners (either horizontal or vertical) are now available free to participating growers. Joe will be contacting the growers for their orders.
 - Kiosk displays will be set up at 4-5 greenhouse test sites around NW Ohio. They will feature locally grown products using the slogan "*From My House To Yours.*"
 - Grower *Retail Cards* will soon be ready for distribution.
 - MVG has contracted for the entire back page of the Lawn and Garden insert in the Toledo Blade and will list all the MVG growers who want to participate. This is a great way to get your greenhouse/garden center's name before more customers at no cost to you. Joe will be sending out either a fax or e-mail for your written permission to place the name and location of your greenhouse/garden center in the ad.
 - MVG has bought 15 second spots before and after *P. Allen Smith* (9:00 a.m.) and *The Victory Garden* (Noon) on Saturdays on WBGU beginning April 15 and continuing through the end of August. These spots will feature the MVG logo and list the MVG website where viewers can find participating growers and gardening information.
 - The MVG website www.maumeevalleygrowers.com goes live April 21st
 - MVG will be submitting two how-to-tips type stories to the Herald for its Home & Garden section next week, plus similar gardening editorial content to other local newspapers.
 - MVG is working with Representative Kaptur and Mayor Finkbeiner to declare the purple trailing petunia (Wave type) the official flower of the Toledo Metro area. Joe will also be talking with Melinda Huntley from Coastal Ohio regarding a more regional approach involving Ohio's native plants. He also wondered if this would open an opportunity for a particular flower or native plant to undergo field/site research. He'll contact Jonathan Frantz at the university. This project may also complement those MVG's more involved in the landscaping business.
 - The Toledo Botanic Garden has generously offered to have one of their segments on Channel 13's Sunday morning programming feature the Maumee Valley Growers. We're looking for a MVG grower that would like to talk about the MVG on this segment. There will be short
