**Old Business: Reports**

- Recycling – Joe Perlaky

Joe reported that pilot program is progressing. At present there are approx. 14-15 Growers interested. Pick-up will be scheduled for twice a year – Spring (May) and in the Fall (October). Wholesalers have the option to call Superior to schedule more pick-ups or drop-offs if necessary. A Marketing Committee is being organized (Paula Ross) to work on banners, flyers (bag stuffers), certification flyer to be posted by businesses involved in program – Roll-out will be Spring 09 at the latest. Logistics as to the type of containers are still being discussed with Superior Packaging.

- Gas Program – Kirk Mizerek

Kirk reported that at present there are over 70 included in gas program pool. There is approximately \$5,000.00 in the Gas Program account. Calls continue to come in from ONLA members who are interested in program. Palmer will begin to invoice the Ohio Gas users on behalf of the MVGA the first of the year.

**New Business: Announcements & Presentations**

- Presentation – Brooks Insurance Agency

Amanda Geletka presented useful advice in order to manage and control cost of risk.

1. Fill out as many AC3 forms to get as many quotes a possible. Deadline: February
2. Businesses need to be a part of sponsoring group for better rates.
3. A structured risk management program will protect the four main asset categories of a business: Organization, Personnel, Property, & Net Income.

- Energy Grants – Joe Perlaky

Joe reported that 23 growers are interested in USDA grant opportunities. Walk thru analysis has been completed at 11 businesses and the remaining will be accomplished next week. The next step: Grant writing team will assist with paperwork.

- Grant Status – Neil Reid

Neil reported that we are still waiting for word.
